- Members asked if N. Commodore Drive, St. Elizabeth Place, and N. Lime Drive will be resurfaced. Mr. Olney will have to verify which roads are on the resurfacing list.

Boulevard Beautification:

- The Contractor is working on growing the flowers for the winter planting.

Grate Installation and Fountain:

- Duke Energy was contacted because the fountain was off for a few days. The fountain is currently working.

Roadway Maintenance / Mowing:

- The mowing contractor has had a change of staff and is working to finish the sections that were not mowed.
